

# CLEAN WATER ACTION'S SCORECARD FOR THE 115TH CONGRESS



Since the start of the 115th Congress in 2017, assaults on basic safeguards for our water, air and health have become more frenzied than ever before. Clean Water Action's Scorecard documents these attacks and shows you how your representatives voted on key environmental legislation.



## The 2016 elections were a turning point. Unfortunately we turned the wrong direction.

Since gaining the majority in 2010, Republicans in Congress have done all they can to undermine protections for our water and health, and put the profits of corporate special interests before the needs of the public. Until 2014 leaders in the Senate were able to stop the worst excesses of the Republicans in the House of Representatives through 2014 and. And until January 2017, until leaving office, the Obama administration acted as a was a backstop, rejecting dangerous bills that would have turned back the clock on safeguards for health and the environment.

Now, since the start of the 115th Congress in 2017, the assaults on the most basic of safeguards for our water, air and health have become more frenzied than ever before. The Republican majority in Congress cheered along as the Trump administration gave up our global leadership in the fight against climate change. Republican leaders in Congress have facilitated Trump's Dirty Water Agenda, eagerly dismantling modest policies like the Stream Protection Rule which had provided communities in coal country with a few tools to protect their drinking water from mountain-top removal coal mining waste. GOP members of the House and the Senate found ways to give even more handouts to the fossil fuel industry and helped Trump install former industry lobbyists and executives in the Environmental Protection Agency, and the Departments of Interior and Energy. And that was just in 2017.

This Congress has refused to hold Administration appointees accountable, allowing Secretary Ryan Zinke to drastically reduce the size of national monuments and they allowed former EPA Administrator Scott Pruitt to waste taxpayer money, start to wipe out protections for drinking water, and sideline career employees despite his very public ethics scandals. Republican leaders have stayed silent as the Trump administration ignored the rule of law, even attempting to help EPA avoid public scrutiny by proposing changes to Administrative Procedures Act, the law that requires agencies to engage the public during the rule-making process.

As you'll see in our Scorecard, Republicans in Congress have prioritized corporate polluters and campaign donors over the public every chance they have had. They have voted to slash agency budgets, undermine the science used to develop safeguards, and more. Republican leaders have allowed the fossil fuel industry and others to put our democracy in a stranglehold.

With the most important elections of the 21st century just around the corner, we hope you'll use these scores as a guide at the ballot box. The people who represent us matter. For too long our Representatives and Senators have cared more about the powerful special interests who call the shots in Washington than people like you and me. It's time to change that.

## 2018 can be a turning point too. It can be the year that we begin to take back Congress and our democracy.

## **Overview**

The U.S. Congress has become increasingly hostile to the environment, climate, public health, and water since 2010. The past eight years have seen frenzied attacks on landmark laws like the Clean Water Act, an ongoing failure to address the climate crisis, and the influence of corporate special interests has become a stranglehold on our democracy. This went into overdrive in 2017, after the election of President Trump. Today, the majority in Congress puts the bottom lines of the fossil fuel industry, industrial agriculture, developers, and other polluters before the health of our environment, the public, or the climate.

Ideologues in the House and the Senate, led by Senate Majority Leader Mitch McConnell and Speaker of the House Paul Ryan, have led this assault, undermining basic protections for our water, walking back our nation's leadership on climate and helping President Trump install corporate cronies in his cabinet. Clean Water Action scored several House and Senate floor votes, including Congressional Review Act resolutions, amendments or "riders" to government funding bills, stand-alone bills like the Farm Bill and the 2017 Tax Reform Bill, and confirmation votes of President Trump's cabinet, agency, and Supreme Court nominees.

**SCORING:** Clean Water Action tallied 33 votes for each Representative and 12 votes for each Senator. Due to the ongoing and historic hostility to environmental protections of the 115th Congress, "NO" was the pro-environment vote for most votes in both the House and Senate. For a perfect 100%, a Member of Congress must vote correctly on all votes for which they register a vote.

Most votes followed party lines — Republicans generally voting against, and Democrats in favor of the environment. Ninety percent of all Republican members of Congress, scored zero or in single digits. While 91% of all Democratic Members of Congress scored 90% or higher, including 168 perfect scores of 100%. The partisan breakdown is clear — Republican Members of Congress favor corporate special interests while putting our health, environment, and climate at risk.

## **The Congressional Review Act**

In the first few months of the Trump administration, Republicans in Congress used an obscure provision, known as the Congressional Review Act (CRA), to repeal more than a dozen regulations that were enacted by the Obama Administration in 2016. One of the first bills signed by President Trump was a CRA resolution that wiped out the Stream Protection Rule, which gave communities near mountaintop removal coal mining operations enhanced information about mining activities. It also provided modest protections for surface water, which many of these communities rely on for drinking water, by requiring coal companies to properly dispose of their mining waste instead of simply dumping it in streams.

The Congressional Review Act was also used to cancel rules to prevent corruption in the oil and gas industry and overturn protections for wildlife in Alaska. Congress attempted and failed to use the CRA to eliminate a rule that would require the oil and gas industry to reduce venting, flaring, and leaks at industry operations on public and tribal lands. Congressional Review Act resolutions require a simple majority in the Senate so they cannot be filibustered. The CRA also prevents "substantially similar" rules from ever being adopted in the future. Prior to 2017, the CRA had only been successfully used to repeal one rule.

### **Nominations**

The Senate has a duty to vet and approve or disapprove of nominees for high level agency positions including cabinet members, federal judges, and nominees for the Supreme Court. The Senate approved Rex Tillerson, former CEO of ExxonMobil to be Secretary of State, Scott Pruitt and

Andrew Wheeler for the top two positions at the Environmental Protections Agency, Ryan Zinke to run the Department of the Interior, and Rick Perry as Secretary of the Department of Energy. Scott Pruitt immediately began to roll back policies like the Clean Water Rule and Clean Power Plan, sideline career officials and scientific advisors, and decrease enforcement actions. He wasted taxpayer money on first class flights and unneeded security enhancements, attempted to leverage his position for personal gain, and got into a series of serious ethics scandals, leading to his resignation and replacement by Andrew Wheeler, the current Acting Administrator. Ryan Zinke is working to reduce the size of several national monuments and open up public land for fossil fuel extraction, while sparking numerous investigations into his ethical lapses, attacks on science, and potential Hatch Act violations. Rick Perry has attempted to prop up the failing coal industry.

## **Riders on Government Funding** and Other Must-Pass Bills

Republicans in Congress have used must-pass funding bills to sneak in attacks on protections for clean water and health that would not pass on their own. By attaching riders to funding bills for EPA or the Farm Bill, Republicans have side-stepped robust debate over unpopular provisions to weaken protections for streams, wetlands, and drinking water. The "Dirty Water Rider" would repeal the 2015 Clean Water Rule, wiping out clear Clean Water Act safeguards for vital parts of our natural water infrastructure. While these provisions have passed the House of Representatives many times, they have yet to pass the Senate.



## Attacks on science, agency budgets, the GOP Tax Scam, and the rider to allow drilling in the Arctic National Wildlife Refuge

The House of Representatives tried to undermine science with several bills. The House has also worked to slash agency budgets including a 33% reduction to EPA. So far the bills to restrict the use of science in health and environmental regulations and to cut agency budgets have not passed in the Senate. Unfortunately the same is not true for an amendment that overturned a 30 year ban on oil and gas drilling in the Arctic National Wildlife Refuge. In late 2017, Congress passed a tax reform bill that wildly benefited corporations and the wealthy. Included in that tax bill was an amendment that opened up this wilderness to fossil fuel extraction, putting wildlife at risk.

Republicans in Congress are putting our health at risk by placing the priorities of corporate polluters and special interests before the needs of the American people. The Dirty Water Agenda in Congress must be stopped.

## **House Votes**

## **1. REINS Act (Regulations from the Executive in Need of Scrutiny Act of 2017)**

This bill would have significantly limited the ability of federal agencies to pass regulations that protect the environment and health. It would have required Congressional approval for any new rules, severely limiting the ability of agencies like EPA to do their job. **The pro-environment vote was NO**.

H.R. 26 passed in the House 237-187 on January 5, 2017. S. 21 introduced in the Senate.

#### 2. Midnight Rules Relief Act

This bill would have allowed Congress to pass multiple Congressional Review Act (CRA) resolutions at once, thereby throwing out dozens of important environmental, health, and other protections simultaneously without debate. **The pro-environment vote was NO.** 

H.R. 21 passed in the House 238-184 on January 5, 2017. S. 34 introduced in the Senate.

#### **3. Regulatory Accountability Act**

The Regulatory Accountability Act would have dangerously slowed the process for issuing and enforcing rules to ensure we have clean air and water, safe food and consumer products, fair wages and safe workplaces, and many other key protections. The bill would have added dozens of burdensome new requirements to the Administrative Procedure Act – increasing the demands on agencies that are already struggling to operate under tight budgets. **The pro-environment vote was NO.** 

H.R. 5 passed in the House 238-183 on January 11, 2017.

#### 4. Regulatory Integrity Act

The Regulatory Integrity Act would have prohibited federal agencies from communicating with the public about proposed regulations. This bill would have stifled participation in the regulatory process and gave more power to influence regulations to special interests, like corporate polluters. **The pro-environment vote was NO.** 

H.R. 1004 passed in the House 46-176 on March 2, 2017.

#### 5. Searching for and Cutting Regulations that are Unnecessarily Burdensome (SCRUB) Act

The SCRUB Act would have established a commission to identify rules and regulations to be repealed. The commission would only consider costs, not benefits of regulations, rendering its decisions useless and not in the public interest. Additionally, the bill would have required agencies adopting new regulations to cut an existing rule with equal or greater cost. **The pro-environment vote was NO.** 

H.R. 998 passed in the House 40-185 on March 1, 2017.

### **VOTES 6-9: Rolling Back Commonsense Protection**

*Congressional Review Act (CRA) Resolutions of Disapproval* Congress could pass CRA resolutions from January 30 through

#### 6. Overturning the Stream Protection From Mountaintop Removal Coal Mining

The Stream Protection Rule, finalized by the U.S. Department of the Interior in Dec. 2016, provided communities with basic information they desperately need about toxic water pollution caused by nearby coal mining operations.

The pro-environment vote was NO.

S.J. Res 10 passed in the Senate 54-45 on February 2, 2017. H.J. Res. 38 passed in the House 228-194 on February 1, 2017. Signed by President Trump on February 16, 2017.

## 7. Overturning the Oil, Gas and Mining Anti-Corruption Rule

The oil anti-corruption rule required U.S.-listed oil, gas and mining companies to publicly report project-level payments made to governments for natural resources in every country of operation. This transparency is key to preventing corruption. **The pro-environment vote was NO.** 

H.R. 71 passed in the House 231-191 on February 1, 2017, and passed in the Senate 52-47 on February 3, 2017. Signed by President Trump on February 14, 2017.

## 8. Overturning the Rule on Methane Waste from Oil and Gas On Public Lands

The U.S. Bureau of Land Management's methane and natural gas rule is a commonsense policy that requires the oil and gas industry to reduce venting, flaring, and leaks at industry operations on public and tribal lands by deploying methane mitigation technology. Repealing this rule would harm public health and the climate and reduce revenue to the federal government and Western states.

#### The pro-environment vote was NO.

H.J. Res. 36 passed in the House 221-191 on February 3, 2017. The bill FAILED in the Senate with a 49-51 vote on May 10, 2017.

#### 9. Overturning Protections for Alaska's Wildlife

The U.S. Fish and Wildlife service issued protections for bears, wolves and other carnivores on Alaska's federal wildlife refuges. Alaska adopted an extreme program that allows for "predator control" methods that include killing mother bears and cubs, killing wolves and pups in their dens, and trapping, baiting, and using airplanes to scout and shoot bears. The Alaska Wildlife Refuge Rule blocked this program on federal lands. This CRA resolution clears the way for these extreme hunting practices.

The pro-environment vote was NO.

H.J. Res. 69 passed in the House 225-193 on February 16, 2017. It passed in the Senate 52-47 on March 21, 2017. Signed by President Trump on April 3, 2017

## 10. Honest and Open New EPA Science Treatment (HONEST) Act

The HONEST Act would have restricted EPA from using scientific research that is not publicly available. This would handcuff EPA and limit the agency's ability to enact protections. This anti-science bill was a direct attack on EPA and its mission of protecting the environment. **The pro-environment vote was NO.** 

H.R. 1430 passed in the House 228-194 on March 29, 2017.

#### **11. EPA Science Advisory Board Reform Act**

This bill would have hindered the ability of the Environmental Protection Agency's Science Advisory Board to reach timely, independent, objective, credible conclusions that can form the basis of policy. The bill would have made it easier for corporate interests like fossil fuel companies, to influence the scientific review process at the agency.

The pro-environment vote was NO.

H.R. 1431 passed in the House 229-193 on March 30, 2017.

## 12. Reducing Regulatory Burdens Act (aka the "Poison Our Waters Act")

The "Poison Our Waters Act" would have gutted Clean Water Act protections from pesticide use. The bill would have allowed for pesticides to be sprayed directly into rivers, lakes, wetlands, or streams without a permit, putting communities that swim, fish, drink, and do business at risk of being poisoned. **The pro-environment vote was NO.** 

H.R. 953 passed in the House 256-165 on May 24, 2017. S. 340 was introduced in the Senate on February 7, 2017.

#### 13. Exempting Water Projects from Environmental Review

The Water Supply Permitting Act would have undermined public input and environmental review for water projects, like dams and surface storage. This bill would undercut our bedrock environmental laws, like the Endangered Species Act and the National Environmental Policy Act (NEPA), by establishing strict deadlines for environmental impact studies, limiting public input, and allowing private companies to pay for expedited permit reviews. **The pro-environment vote was NO.** 

H.R. 1654 passed in the House 233-180 on June 22, 2017.

#### 14. Fast-tracking Gas Pipelines

The "Promoting Interagency Coordination for Review of Natural Gas Pipelines Act" would have subverted state and local government agencies, undercut public transparency, and limited environmental review in the permitting of new gas pipelines. It would have given ultimate authority to the Federal Energy Regulatory Commission (FERC), an agency with a poor record of environmental protection, to issue pipeline permits with minimal environmental protections and public participation. **The pro-environment vote was NO. H.R. 2910 passed in the House 248-179 on July 19, 2017.** 

#### 15. Perry Amendment to the NDAA (Military Preparedness and Climate Change)

This amendment to the must-pass National Defense Authorization Act (NDAA) would have blocked a study on the impacts of climate change on the military. It would have also removed language that recognizes climate change as a direct threat to national security. **The pro-environment vote was NO. H. Amdt. 179 to H.R. 2810 failed in the House 185-234 on July 13, 2017.** 

**VOTES 16-22:** In 2018, President Trump and Republicans in Congress pushed for a federal budget with deep cuts to critical environmental programs, and ideological policy riders that would gut clean water and other health and safety protections.

#### **16. House Interior, Environment and Related Agencies Appropriations Bill**

The House spending bill was a budget and policy rider disaster. It included cuts to vital programs that protect our water and air, including more than \$500 million in cuts to EPA, \$250 million of which are cuts to the Clean Water State Revolving Fund. The bill also included reckless policy riders, such as an amendment that would have exempted the Trump Administration from following the rule of law as they roll back Clean Water Act protections. **The pro-environment vote was NO.** 

H.R. 3354 passed in the House 211-184 on September 14, 2017.

#### 17. Amendment No. 50: Undermine the Chesapeake Cleanup

Goodlatte (R-VA), Perry (R-PA), Thompson, Glenn (R-PA), Shuster (R-PA) This amendment would have prohibited EPA from using any funds to implement "backstop" actions against any of the six states in the Chesapeake Bay Watershed in the event that a state does not meet the goals mandated by EPA's Chesapeake Bay cleanup plan. **The pro-environment vote was NO**. **The amendment passed 214-197**.

### **HOUSE VOTES** continued

#### **18. Amendment No. 57: No Offshore Fracking** *Carbajal (D-CA)*

This would have prohibited funds from being used to process any application that would authorize use of hydraulic fracturing or acid well stimulation treatments in offshore wells in the Pacific Outer Continental Shelf. **The pro-environment vote was YES.** 

The amendment failed 177-230.

#### **19. Amendment No. 63: Undermining BLM Methane Emissions Rules** *Pearce (R-NM)*

This would have prevented funds from being used to implement the Bureau of Land Management's rule to reduce methane waste and leakage from oil and gas facilities on public lands. **The pro-environment vote was NO.** 

The amendment passed 216-186.

#### **20. Amendment No. 73: Undermining EPA Methane Emissions Rules** *Mullin (R-OK)*

This would have prohibited funds for enforcing the Obama Administration's EPA rule to limit methane emissions from oil and gas facilities. **The pro-environment vote was NO.** 

The amendment passed 218-195.

#### 21. Amendment No. 74:

#### **Undermining the Social Cost of Carbon Rule**

*Mullin (R-OK), Perry (R-PA)* This provision would have prohibited funds for implementing the Obama Administration's Social Cost of Carbon rule. **The pro-environment vote was NO.** 

The amendment passed 225-186.

#### **22. Amendment No. 75: Protect EPA Offices** *Polis (D-CO)*

This would have prohibited funds from being used to close or consolidate any regional office of the Environmental Protection Agency. **The pro-environment vote was YES. The amendment failed 201-212.** 

#### 23. Tax Scam and Arctic Oil Drilling

The tax scam bill provided massive tax cuts to the wealthiest Americans and corporations by selling out the environment and public health. The tax bill will end up raising taxes on most Americans in the long-term, while cutting taxes for big polluters and extending dirty energy tax preferences. It will likely lead to cuts of important programs that protect our environment, health, and well-being. The bill also opened the Arctic National Wildlife Refuge to oil drilling, which would cause irreversible damage to the home of the Gwich'in people and pristine wildlife habitat. **The pro-environment vote was NO.** 

The final conference report for H.R. 1, passed in the Senate 51-48 on December 19, 2017 and passed in the House 224-201 on December 20, 2017. It was signed into law on December 22, 2017.

#### 24. The Farm Bill: Dirty Water Rider

The House voted to attach a rider to the Farm Bill (May 2018 House version) that would have repealed the Clean Water Rule. This Dirty Water Rider would have removed federal protections for small streams and wetlands, endangering the drinking water sources for 117 million Americans.

#### The pro-environment vote was NO.

Amendment 633 (Banks) passed in the House 238-173 on May 18, 2018. The full bill, H.R. 2 later failed.

#### 25. Farm Bill

The House Farm Bill (June 2018 version) would have repealed the Clean Water Rule, removed protections from pesticide spraying in waters, slashed conservation funding, weakened protections for endangered species, and many other rollbacks. It would have also forced thousands of people off of Supplemental Nutrition Assistance Program (SNAP, or food stamps) benefits. **The pro-environment vote was NO**.

H.R. 2 passed in the House 213-211 on June 21, 2018.

#### 26. Fiscal Year '19 House Interior-Environment Minibus

This spending bill included numerous harmful policy riders, including a repeal of the Clean Water Rule. It also would have slashed EPA's budget, cutting funding for vital programs. **The pro-environment vote was NO.** 

H.R. 6147 passed in the House 217-199 on July 19, 2018.

#### 27. Amendment #50:

#### **Undermining Chesapeake Bay Protection**

This amendment would have prohibited EPA from implementing "backstop" actions against any of the six states in the Chesapeake Bay Watershed in the event that a state does not meet the goals mandated by the EPA's Chesapeake Bay cleanup plan. **The pro-environment vote was NO.** 

The amendment passed in the House 213-202 on July 18, 2018.

#### 28. Amendment #46:

#### Making Seafood and Fishing Less Safe

The amendment would have prohibited the implementation of safeguards that protect communities from contaminated seafood that could contain PCB's, mercury and other toxics. **The pro-environment vote was NO.** 

The amendment passed in the House 217-185 on July 18, 2018.

### **HOUSE VOTES** continued

#### 29. Amendment #44: Ignoring Social Cost of Carbon

The amendment would have prevented the federal agencies from considering the costs of climate change in decisions. **The pro-environment vote was NO. The amendment passed in the House 215-199 on July 18, 2018.** 

30. Amendment #43: Blocking Oil and Gas Methane Rules

This amendment would have prevented EPA from implementing regulations that reduce methane emissions from new or modified oil and gas wells and other infrastructure. **The pro-environment vote was NO.** 

The amendment passed in the House 215-194 on July 18, 2018.

#### **31. House Energy and Water Minibus**

This was another terrible spending bill from the House. It included the Dirty Water Rider to repeal the Clean Water Rule, as well as numerous other anti-environmental riders and inadequate spending on clean energy programs. **The pro-environment vote was NO.** 

H.R 5895 passed in the House 235-179 on June 8, 2018.

#### 32. Attack on Oceans and Sustainable Fishing

This bill reauthorizes and weakens US law on fishery management, known as the Magnuson–Stevens Act. It would weaken sustainability requirement and remove accountability for overfishing. **The pro-environment vote was NO. H.R. 200 passed in the House 222-193 on July, 11 2018.** 

#### 33. Anti-Carbon Tax Resolution

This symbolic resolution asserted that it is the position of Congress to oppose putting a price on carbon. **The pro-environment vote was NO.** 

H.Con.Res 119 passed in the House 229-180 on July 19, 2018.



## **Senate Votes**

#### **VOTES 1-6: Confirmation Votes**

The Senate has a duty to vet and approve or disapprove of nominees for high level agency positions including cabinet members, federal judges, and nominees for the Supreme Court.

1. Rex Tillerson, Secretary of State The pro-environment vote was NO. Confirmed on February 1, 2017 with a vote of 56-43.

#### 2. Scott Pruitt, EPA Administrator

The pro-environment vote was NO. Confirmed on February 17, 2017 with a vote of 52-46.

#### 3. Rick Perry, Secretary of Energy

The pro-environment vote was NO. Confirmed on March 2, 2017 with a vote of 62-37.

#### 4. Neil Gorsuch, Supreme Court

The pro-environment vote was NO. Confirmed on April 7, 2017 with a vote of 54-45.

#### 5. Ryan Zinke, Secretary of Interior

The pro-environment vote was NO. Confirmed on March 1, 2017 with a vote of 68-31.

#### 6. Andrew Wheeler, Deputy EPA Administrator

(Wheeler is now Acting EPA Administrator) The pro-environment vote was NO. Confirmed on April 12, 2018 with a vote of 53-45.

The U.S. Bureau of Land Management's methane and natural gas rule is a commonsense policy that requires the oil and gas industry to reduce venting, flaring, and leaks at industry operations on public and tribal lands by deploying methane mitigation technology. Repealing this rule would harm public health and the climate and reduce revenue to the federal government and Western states.

#### The pro-environment vote was NO.

H.J. Res. 36 passed in the House 221-191 on February 3, 2017. The bill FAILED in the Senate with a 49-51 vote on May 10, 2017.

#### 11. Tax Scam and Arctic Oil Drilling

The tax scam bill provided massive tax cuts to the wealthiest Americans and corporations by selling out the environment and public health. The tax bill will end up raising taxes on most Americans in the long-term, while cutting taxes for big polluters and extending dirty energy tax preferences. It will likely lead to cuts of important programs that protect our environment, health, and well-being. The bill also opened the Arctic National Wildlife Refuge to oil drilling, which would cause irreversible damage to the home of the Gwich'in people and pristine wildlife habitat. **The pro-environment vote was NO**.

The final conference report for H.R. 1, passed in the Senate 51-48 on December 19, 2017, and passed in the House 224-201 on December 20, 2017. It was signed into law on December 22, 2017.

#### 12. Blocking the Dirty Water Rider: Amendment to Senate Energy and Water Minibus

This procedural vote blocked the Dirty Water Rider from being added to the Senate Appropriations bill, helping to preserve a relatively clean spending bill. The Dirty Water Rider would have repealed the 2015 Clean Water Rule. **The pro-environment vote was YES.** 

The Senate passed the motion 62-34 on June 21, 2018.
